Dear Participant:

The Board of Trustees is pleased to announce that effective February 1, 2015, we are transitioning the prescription drug coverage back to Sav-Rx Prescription Services as our Pharmacy Benefit Manager.

Sav-Rx will be sending you cards and a welcome letter containing important information. Please share these cards with your pharmacist starting February 1, 2015, so that you don't experience any problems having your prescriptions filled.

The Plan's prescription drug benefits are not changing – all the co-pays and participant-paid portions remain the same.

To access Sav-Rx's Pharmacy Locator, please visit www.savrx.com. You may also call the Sav-Rx Customer Service at (866) 233-IBEW to confirm your pharmacy is in the network. **Remember - Walmart and Sam's Club Pharmacies are excluded from the coverage network due to their non-union policies.**

Sav-Rx provides **mail order service**, which is an excellent way to receive prescriptions you will be taking for a long time with no worries about weather or availability of supply at the local pharmacy. For individuals who are taking maintenance medications, you may want to consider utilizing the mail order service for the convenience of home delivery.

Inside your Sav-Rx welcome package with your identification cards, you will also receive information about mail order services. If you use the mail order service, **you may need to obtain new 90 Day supply prescriptions from your physician. However, whenever possible, Sav-Rx will contact your physician on your behalf. Please contact Sav-Rx at 866-233-IBEW with your prescription and prescriber information.** If you have an original prescription(s) written for a 90-day supply of your medication (plus refills, if applicable), please mail to Sav-Rx with the mail-order form located inside your Sav-Rx brochure, along with your first payment or payment information. Please note that pre-payment is required with all orders.
